Bids will be opened in the presence of Bidders' representatives who choose to attend in person at the Office of the Birtamode Municipality, Office of Municipal Executive, Birtamode, Jhapa, immediately after the submission deadline as stated on above table.

- Information or data submitted by the bidder which is either incomplete or unclear or not substantiated by supporting documents shall not be considered for evaluation.
- Bidders are advised to visit site and assess the actual site conditions before submitting their bid.
- If the last date of purchasing and/or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
